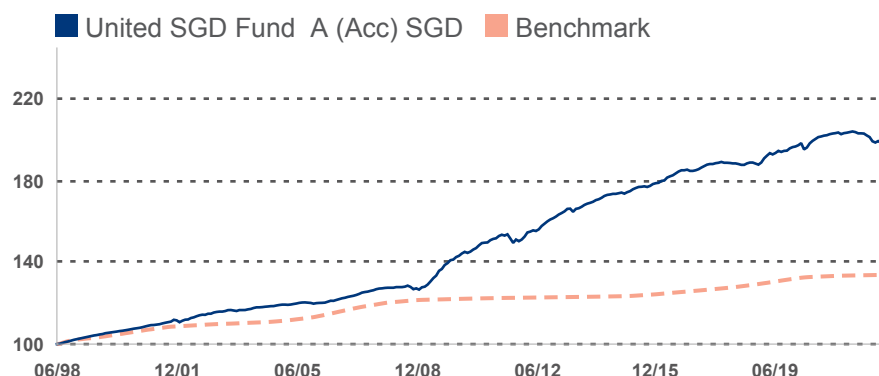


United SGD Fund

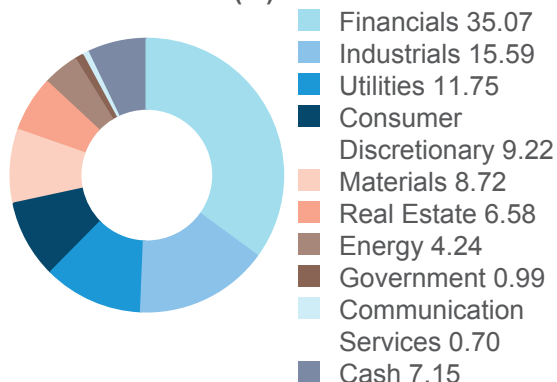

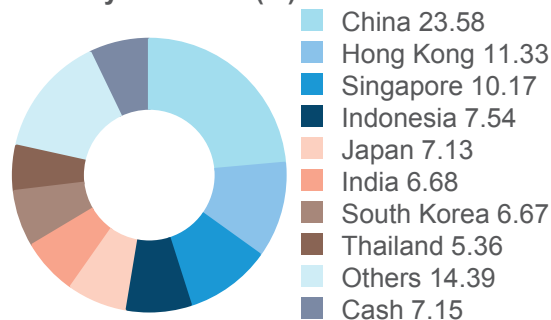
